In pursuance of the decision taken by the Academic Council vide Item no. 8 in its 11th meeting held on 23.04.2024 and consequent approval of the Board of Management vide item no. A-11 of its 9th meeting held on 14.05.2024, the Hon'ble Vice-Chancellor, MHU is pleased to add the following notes below Clause 6.1, 6.2, 6.3 and 6.4 of Chapter XXI-A of Statutes:-

Note-1 & 2 below Sub Clause (d) of Clause 6.1 of Ch.-XXI-A:

Note-1: The conditions at (b), (c) and (d) shall be mandatory requirement. The teachers may still be placed in the next stage even if they do not fulfil the requirement at (c) above but they will have to fulfil the same by 31.12.2018. However, the placement of teachers in the next stage under CAS be considered only when they fulfil the condition of refresher course/orientation course/research methodology course by 31.12.2018 but the promotion will be given w.e.f. due date. In case they fulfil the condition after 31.12.2018 they will be considered for promotion from the date they fulfil the condition after 31.12.2018.

That the grant of next stage will be made from due date only after the teacher fulfils the condition of refresher course/orientation course/research methodology course by 31.12.2018.

Note-2: Where next stage has been granted subject to condition that a teacher will fulfil the requirement by 31.12.2018 and if such condition is not fulfilled by this date, his /her promotion under CAS will be withdrawn consistent with the guidelines of the ICAR.

Note-1 & 2 below Sub Clause (d) of Clause 6.2 of Ch.-XXI-A:

Note-1: The conditions at (b), (c) and (d) shall be mandatory requirement. The teachers may still be placed in the next stage even if they do not fulfil the requirement at (b) above but they will have to fulfil the same by 31.12.2018. However, the placement of teachers in the next stage under CAS be considered only when they fulfil the condition of refresher course/ methodology workshop/training/ and Faculty Development Programme by 31.12.2018 but the promotion will be given w.e.f. due date. In case they fulfil the condition after 31.12.2018 they will be considered for promotion from the date they fulfil the condition after 31.12.2018.

That the grant of next stage will be made from due date only after the teacher fulfils the condition of refresher course/ methodology workshop/training/ and Faculty Development Programme by 31.12.2018.

Note-2: Where next stage has been granted subject to condition that a teacher will fulfil the requirement by 31.12.2018 and if such condition is not fulfilled by this date, his /her promotion under CAS will be withdrawn consistent with the guidelines of the ICAR.

Note-1 & 2 below Sub Clause (v) of Clause 6.3 of Ch.-XXI-A:

Note-1: The conditions at (ii), (iii), (iv) and (v) shall be mandatory requirement. The teachers may still be placed for promotion as Associate Professor/equivalent even if they do not fulfil the requirement at (ii) above but they will have to fulfil the same by 31.12.2018. However, the placement of

teachers for promotion as Associate Professor/equivalent under CAS be considered only when they fulfil the condition of refresher course/training/ Faculty Development Programme by 31.12.2018 but the promotion will be given w.e.f. due date. In case they fulfil the condition after 31.12.2018 they will be considered for promotion from the date they fulfil the condition after 31.12.2018.

That the grant of promotion as Associate Professor will be made from due date only after the teacher fulfils the condition of refresher course/Training/ and Faculty Development Programme by 31.12.2018.

Note-2: Where promotion as Associate Professor has been granted subject to condition that a teacher will fulfil the requirement by 31.12.2018 and if such condition is not fulfilled by this date, his /her promotion as Associate Professor will be withdrawn consistent with the guidelines of the ICAR.

Note-1 & 2 below Sub Clause (d) of Clause 6.4 of Ch.-XXI-A:

Note-1: The conditions at (b), (c) and (d) shall be mandatory requirement. However, if the requirement of orientation course/refresher courses remains incomplete, the grant of promotion as Professor/equivalent would not be held up. But these must be completed by 31.12.2018. However, the placement of teachers for promotion as Professor/equivalent under CAS be considered only when they fulfil the condition of refresher course by 31.12.2018 but the promotion will be given w.e.f. due date. In case they fulfil the condition after 31.12.2018 they will be considered for promotion from the date they fulfil the condition after 31.12.2018.

That the grant of promotion as Professor will be made from due date only after the teacher fulfils the condition of refresher course/summer institutes by 31.12.2018.

Note-2: Where promotion as Professor has been granted subject to condition that a teacher will fulfil the requirement by 31.12.2018 and if such condition is not fulfilled by this date, his /her promotion as Professor will be withdrawn consistent with the guidelines of the ICAR.
